Preservation

Shelf life :	24 months
Preservation method :	Dried product, fumigated to kill insect.
Storage conditions :	Dried, dark, airy and tempered area.

Instruction for use

Rinse the mushrooms thoroughly in lukewarm water, then place into a small bowl and fill with hot water. Allow to soak for 15 minutes then drain. Then plunge your mushrooms into boiling water for one minute and drain. Your favorite wild mushrooms are now ready for cooking.

Traceability of the product

Checks at critical points during the process according to the HACCP method.
Weight checks on every batch.
Recording batch numbers of raw material until the finish product.
Identification of batch number and shelf life.
Mechanical and manual sorting out, X-ray and metal detection.
